Seminar in Academic Writing: Empathy & Activism Essay 2: Frame & Case Essay

In this composition, you will find and draw upon additional research on activism to examine how our course concepts of empathy and activism are utilized in one specific site of change, such as a text, movement, or organization. Srikanth, Martin, Hanson, and Fontaine's works will help you create a framework of empathy through which you will examine your site of change as a case study. Looking at one specific case study will enable you to extend a larger argument about activism overall.

To do this, you will need to select your initial site of resistance and research how those involved with it have engaged in activism. You will then research additional scholarly studies of activism or about site of change with a focus that helps you analyze your specific text, movement, or organization. Your research will help you learn more about the objectives and issues surrounding activism as well as refine and redirect class conversation. You will then analyze and question how your site of resistance engages in a social movement. How do their actions reflect some of the larger concerns we have about activism, empathy, and the goals we place on them? How are they working as allies or advocates/accomplices? How might you or others critique them? *Note:* I encourage you to use a site of change that is involved in the same topic as your **Social Engagement Project**.

Students will

- Identify & learn about a specific artifact/site of resistance
- Engage in research on the scholarly conversation surrounding activism
- Read and engage with one scholarly text focusing on an issue related to activism
- Use their archive of knowledge about activism and empathy to analyze how their site of resistance engages in a social movement
